**RIDER'S RELEASE AGREEMENT 2021**

WHEREAS, SANDRA CARNET AND JEAN CARNET d/b/a/ OXER FARM LLC/OLD BONNER PLACE (hereinafter "OXER FARM") has made available to the undersigned, or to the child of the undersigned, or both, all or a portion of the property, equipment and facilities of OXER FARM, and the property known as Old Bonner Place/Piney Woods in Eatonton, Georgia including, but not limited to, riding areas, trails, stables, equipment, horses, and instruction, the undersigned hereby assumes full responsibility for the safety of the Rider.

The term Rider shall mean not only the undersigned, but also, any minor of the undersigned, and also any person who uses any portion of the property, equipment, horses or facilities of OXER FARM with permission of the undersigned. Undersigned hereby releases SANDRA CARNET, JEAN CARNET, OXER FARM, any landowner, their agents, employees, successors, assigns, legal representatives, heirs, executors and administrators from any and all claims, causes of action, demands, obligations and liabilities – which are now existing or hereafter mature or accrue at any time – arising out of or related in any fashion to Rider's use of OXER FARM property, equipment or facilities, except for OXER FARM's gross negligence or OXER FARM's intentional acts.

The undersigned acknowledges and fully understands that the Rider uses the property, equipment and facilities of OXER FARM at his or her own risk. The undersigned hereby agrees to hold and save OXER FARM, SANDRA CARNET, JEAN CARNET, any landowner, their agents, employees, successors, assigns, legal representatives, heirs, executors and administrators harmless from each and every claim, demand, liability or other obligation which may arise out of or be connected in any fashion with loss, injury, or damage to the Rider or to the Rider's property. The undersigned hereby agrees and covenants not to bring any action at law or in equity against SANDRA CARNET, JEAN CARNET, OXER FARM, any landowner, their agents, employees, successors, assigns, legal representatives, heirs, executors or administrators on behalf of the undersigned or on behalf of Rider, whether minor or adult, arising from or relating in any fashion to any injury, damage or other loss suffered by Rider and connected in any fashion with Rider's use of OXER FARM property, horses, equipment or facilities, and the undersigned shall further defend SANDRA CARNET, JEAN CARNET, OXER FARM any landowner, their agents, employees, successors, assigns, legal representatives, heirs, executors or administrators against any such actions brought by Rider or on Rider's behalf with respect to the Rider's use of OXER FARM property, horses, equipment or facilities, and the undersigned shall indemnify OXER FARM, their agents, employees, successors, assigns, legal representatives, heirs, executors or administrators for anything for which Rider is responsible either alone, jointly or severally.

The undersigned hereby acknowledges and understands that SANDRA CARNET, JEAN CARNET, OXER FARM , their agents, employees, successors, assigns, legal representatives, heirs, executors and administrators do not represent or warrant the quality or character or any horse furnished to or owned by Rider or the quality of any instruction provided by any individual to the Rider. Furthermore, the undersigned acknowledges and understands that horseback riding or other participation in activities at OXER FARM may involve substantial risk of bodily injury, property damage and other dangers including but not limited to bodily injury or death resulting from kicks and bites, falling off horses or horses falling on Rider, being dragged by a foot caught in the stirrups, Rider being thrown by horse, equipment failure or collision with horses or vehicles or other inanimate objects.

In the event Rider or any of the designated individuals is a minor, the undersigned, on behalf of said minor, does hereby consent to any x-ray, anesthetic, medical or surgical diagnosis or treatment and hospital service that may be rendered to said minor under the general or specific instructions of any physician or hospital. The undersigned acknowledges that this consent to medical treatment is given in advance of any specific diagnosis or treatment which may be required, but is given to encourage OXER FARM, any hospital staff and physicians to exercise their best judgment as to the requirements of such diagnosis or treatment. The undersigned hereby agrees to pay all fees and expenses of doctors, hospitals, ambulances and other medical expenses reasonably and necessarily incurred.
